2. Organizing and conducting seminars, qualification and requalification courses, information meetings and sessions.
3. Implementing interaction and cooperation with national and international organizations with economic and non-economic purposes, state and municipal bodies in connection with achieving the association's goals.
4. Developing programs for qualification, requalification, awareness and professional development.
5. Developing and proposing projects for methodologies and normative acts to competent institutions in accordance with the association's objectives.
6. Cooperation with various media and mass media to reach a wider public and promote the association's objectives.
7. Providing assistance in connection with the provision of medical care and services; assistance and preparation of documents for mothers with children in connection with admission to nurseries, kindergartens and educational institutions.

6d. Subject of Additional Economic Activity

The ASSOCIATION may also carry out additional economic activities related to the main objectives of the ASSOCIATION: providing consultations, projects, analyses for a specified fee; organizing paid informative, educational and training events; establishing and participating in commercial companies. The ASSOCIATION will use the income from the activity in the above point to achieve the objectives of the ASSOCIATION.
